

## White Oak Borough 75th Anniversary Kickball Tournament Waiver of Liability Form

### Waiver of Liability, Release, Assumption of Risk & Indemnity Agreement (required for participation):

I understand that I, or where applicable, my child, will be solely responsible for the actions, conduct, and safety of the participant during the White Oak Borough 75<sup>th</sup> Anniversary Kickball (hereinafter "Tournament") including following all rules, regulations, and instructions. I understand that there are certain risks, dangers, and hazards inherent in participation in the Tournament and the activities incidental or related thereto that can result in personal injury. I knowingly and voluntarily assume all known and unknown risks of injury, illness, or other harm due to any act, event, or omission related to my participation. I understand that participation is entirely voluntary. I understand that, if the terms of this Waiver of Liability Form are unacceptable to me, I or my child should not participate and will not be permitted to participate in the Tournament or related activities.

For and in consideration of my, or where applicable, my child's registration for the Tournament and being allowed to participate in said Tournament, I hereby forever remise, release and discharge the Borough, its elected officials, employees, agents, insurers, other Tournament participants, coaches, officials, Tournament sponsors and owners of the site of the Tournament competition, (hereinafter "Releasees"), of and from all manner of liability, actions, claims, causes of action, suits, judgments and demands whatsoever, arising out of my and/or my child's participation in the Tournament and related activities and any injury, disability or death or loss or damage to property resulting from such participation. I also agree to indemnify and hold harmless Releasees from and against any and all claims, suits, procedures, costs, expenses, damages and liabilities, including reasonable attorneys' fees, brought as a result of my and/or my child's participation in the Tournament and related activities.

I acknowledge that I have been provided and have read the above paragraphs and have not relied upon any representations of Releasees in choosing to execute this agreement.

In the case where a captain is registering a team, the registering captain agrees to inform all participants on their roster that they must individually execute a copy of this agreement before they will be permitted to participate in the Tournament. In the event that a participant is a minor, a parent or legal guardian must sign this Waiver of Liability on behalf of the minor participant and such signature shall have the same force and effect as if the minor were able to consent on his or her own behalf.

If signing on behalf of a child, I understand that I am waiving and releasing any right of the child and any right that any parent or guardian might have to sue or make claim against the Releasees for any act or omission, event, or injury to the child that they might sustain during the course of or arising out of the Tournament.

I HAVE CAREFULLY READ THIS AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS AGREEMENT INCLUDES A WAIVER OF LIABILITY AND RELEASE, AN ASSUMPTION OF RISK, AND AN AGREEMENT BY ME TO INDEMNIFY THE RELEASEES, AND I SIGN IT OF MY OWN FREE WILL.
